## Forsyth County Public Library Board of Trustees Summary of Action Taken at November 12, 2018 Meeting

The Forsyth County Public Library Board of Trustees held its **November** meeting at the Cumming Library on November 12, 2018 at 5:30 p.m.

Present were Board members Tim Plotner (Chairman), Mary Helen McGruder, Kristin Morrissey, Kathy Thomas, and Christy Winters. The following is a summary of action taken at this meeting:

The Board voted unanimously to make the following adjustments to the Fiscal Year 2019 budget:

- Increase Donations revenues and Operations expenses by \$1,100 to reflect donations from FCPL Friends & Advocates for Staff Day and the 2019 Forsyth Reads Together event.
- Increase State revenues and Operations expenses by \$13,008.40 to reflect a 2018 rollover Lib Tech grant.
- Increase State revenues and Operations expenses by \$19,415.35 to reflect a FY2019 Lib Tech grant.
