The Forsyth County Public Library Board of Trustees held its March meeting at the Cumming Library on March 16, 2020 at 5:30 p.m.

The Board voted unanimously to decrease Personnel expenses by \$104,056 and increase Operations expenses by \$104,056 to purchase furniture for the Cumming Library.
