The meeting was held via simultaneous conferencing (visual and audio) for the Library Board and staff and was simultaneously available to the public.

There was a motion by Mary Helen McGruder and a second by Tim Plotner to increase State revenues and Materials expenses by \$19,704 due to restoration of State Materials funding initially cut in January 2020. Motion carried unanimously, with all Board members present.
